Preface

The growing complexity of the development/humanitarian endeavour in Kenya, the increasing variety of actors, the blurring of some NGO regulation and the incidence of humanitarian disasters, particularly related to climate change are the sort of challenges that require collective action by NGOs if they are to be addressed successfully.

The main reason for establishing an Italian NGO coordination body in Kenya originated indeed from the recognition that collective action can achieve common goals more effectively than individual initiatives. This unpretentious principle brought together in 2015 more than 35 Italian NGOs and paved the way for the set up of the NGO-led coordination body named COIKE, “Coordination of Italian NGOs in Kenya”. The aim is to establish a more visible and effective coordination mechanism and ensure appropriate, adequate and timely information flows between all stakeholders involved and to create space to discuss and resolve common positions.

COIKE recognises the central role of governmental and inter-governmental organisations top-down coordination structures in Kenya and their crucial effort in attempting to regulate and generate order on the chaotic NGO sector in Kenya.

At the same time, history is teaching us that top-down and externally led NGO coordination mechanisms have higher chances to fail to take root, while coordination structures generated and supported by NGOs themselves, such as COIKE, tend to show great resilience.

Based on these assumptions, COIKE is proud of supporting the present publication *Nia Moja, One Aim, Una Meta - Experiences of Italian NGOs in Kenya* together with the Italian Agency for Development Cooperation and the Embassy of Italy in Kenya.

The publication intends to provide information about NGOs, Trusts and other Not for Profit entities registered in Italy and operating in Kenya. The book contains stories, photos, analysis and figures that will generate better understanding on the great efforts done by more than 30 Italian NGOs in Kenya in the last 5 years.

The list of Italian NGOs and their recent main achievements described in the present publication does not intend to be exhaustive but it has to be considered the first step to share more light into the solid and deeply rooted partnership between Italian and Kenyan people and their civil society organizations, marked by friendship and cooperation in various sectors.

In acknowledging the help received from the




Introduction




Italian Non-governmental organisations have become key actors in responding to poverty and humanitarian crises in Kenya. They play a crucial role in providing services and promoting social justice as well as complementing the Government of Kenya in the socio-economic development efforts.

The vast majority of the programs and activities implemented by the Italian NGOs envision a strong collaboration with local partners from the civil society organizations and/or from the local government. The operational strategies employed to reach the intended beneficiaries varies between direct and indirect interventions through local NGOs/CBOs, depending on the service to be delivered and the institutional configuration on the ground. The review offers an analysis on the great impact in terms of partnership with local stakeholders as well as the high number of local job creation within the Italian NGO sector.


LOCAL PARTNERS

Most of the resources mobilised by Italian NGOs in Kenya come from public funds. The European Union and the Italian Cooperation have been the major historical donors for this sector in the country. Furthermore, several funds are mobilised through private donors such as foundations or individual families and religious

related funds (e.g. the Conference Bishops in Italy and the Waldensian Evangelical Church). An important contribution is made available by the 5x1000 donations, an income tax return mechanism in Italy that has enabled the Italian NGOs to mobilise a considerable amount of resources for the Kenya programs.

It aims to make the NGOs interventions better organised and more professional, facilitating the linkages with local authorities, local civil society and other stakeholders.





SECTOR DISTRIBUTION



FOCUS AREAS



The Community of Sant'Egidio ACAP is a non-Governmental, non-profit Organization founded in 1973 in Italy to coordinate the social and cooperation activities of Sant'Egidio, a public lay association of the church, born in Rome in 1968. Its main goal is "the promotion of justice, peace, development, international cooperation and protection of human rights".

The CSE ACAP is recognized as an NGO and is registered in the list of the Civil Society Organization according to the law n.125 of 2014. In 2002 the CSE designed and set up DREAM a programme that aims to fight the HIV/AIDS epidemic and other diseases in sub-Saharan Africa. The programme is now active in eleven African countries, in collaboration with local governments: Mozambique, Malawi, Tanzania, Kenya, DRC, Cameroon, Nigeria, Angola, Guinea, Swaziland, Central African Republic. Moreover, CSE ACAP is also present in other countries, such as Guatemala, Salvador, Albania, Burkina Faso, where it works in support of children education, civil registration of children, support of vulnerable people such as people with disabilities.



Focus in Kenya

In Kenya, the Community of S. Egidio started to operate in 2005 especially in health sector with the DREAM Programme, conducted in collaboration with the local partner DREAM Kenya Trust. The Programme supports 8 health centres in the towns of Nairobi, Chaaria, Nkubu, Kyeni, Chakariga, Nchiru, Tunyai. DREAM has been working with the communities to provide care and treatment to affected people belonging to the most vulnerable groups. The HIV epidemic in Kenya has evolved to become one of the major causes of mortality and burden on the health system and the economy. The socio-economic impact of the HIV epidemic is reflected in the increase in number of orphans and vulnerable

children, single-parent headed households, erosion of household incomes and inaccessibility to basic needs, stigma and discrimination of persons infected and affected by HIV; all resulting in deepening poverty and added constraints to economic growth. 1.5 million people are estimated to be living with HIV in Kenya.

The strategy of DREAM Programme is to offer a comprehensive package of services free of charge, to maximize access to care: test and counselling, medical visits, provision of Antiretroviral Drugs, TB screening, cervical cancer screening, prevention of mother to children transmission, laboratory monitoring. The programme is conducted mainly by local staff, with the support and training of international experts. Ongoing training is one of the key elements of the programme, as well as the computerization of the whole process of care and the patient centred approach, which allowed to obtain excellent results in term of patient's adherence, elimination of mother to child transmission, efficacy of treatment.

CSE ACAP has also set up three laboratories. DREAM Programme works in close collaboration with the Ministry of Health, the county and also with other local partners such as other Italian NGO working in the same regions (such as AINA), or religious congregations working in the health sector (Daughters of Charity, Ursuline Sister of Gandino). CSE ACAP also worked in the area of food security especially during the droughts in the Eastern Region, mainly constituted by arid and semiarid lands, distributing food to the affected population.

At the moment 4 projects are active in Latin America (Ecuador and Bolivia) and Africa (Kenya and Chad).

Focus in Kenya

Ai.Bi is an Italian organization with presence in 34 countries across the world and has operated in Kenya since 2011.

Focus in Kenya

Ai.Bi. Friends of children operates where abandonment manifests itself: in orphanages, in care centers, on the streets, within the families. Children living in disadvantaged and in difficulty families are often at great risk of abandonment. In order to defend their fundamental right to have a peaceful childhood, we supports families and children with international cooperation projects, national and international adoption.

Ai.Bi main targets are the most vulnerable children with their families, the care leavers, the CCI's and the local institution in order to create the conditions for an improvement of the children environment in Kenya and to promote mechanisms for the social inclusion and the economic independence of care leavers.

Ai.Bi Kenya mainly works with the following schools and CCI partners:

Sancare Preparatory School

A centre of excellence and quality education, in Huruma (Nairobi). Sancare Preparatory School is a private day school offering 8-4-4 curriculum. The school is founded on Christian principles, values and teaching that form a strong moral background for the school community.

Kwetu Home of Peace

A rehabilitation Centre for street boys between ages 8-14 years. Established in 1993, in Madaraka (Nairobi) in response to increasing number of children on the streets of Nairobi. Kwetu and AiBi's goal is to ensure that street children are rehabilitated and developed to their full potential to become productive members of society.



Vijiji Home of Light

Vijiji Home of Light is a CCI (Charitable Children's Institution) funded in 2007, in Isinya (Kajiado). The Home carter and cares for children who had been living in many different, but difficult circumstances from Nairobi and its environs. These include and are not limited to: the abandoned, orphans, destitute, victims of cruelty, neglect and abused physically, psychologically and sexually and those unwanted by their biological parents and others.

Shelter Children Home

Shelter Children Rehab Center is a childcare programme situated on the outskirts of Nairobi next to the Ngong - Kibiko Area. SCH aims to empower children to fulfill their potential and give orphans and vulnerable children a foundation of security and hope to build a sustainable life.

Amani Organization - Italian Cooperation - Kenya Office

FOCUS AREAS



Amani started its activities in 1995 in Kenya and Sudan and was officially registered as an NGO in Italy in 1996. Amani is currently implementing in Kenya and Zambia (Lusaka) programs on child protection in partnership with Koinonia Community, its local counterpart in Africa.

Focus in Kenya

Amani is present in Kenya since 1995. The main sector of Amani and Koinonia's interventions is the Child Protection sector, although the two organizations run also program concerning youth, education and the health sector through the work of a dispensary based in Riruta Satellite.

Following are the four principles of the strategy of intervention:

Prevention

Working directly with families of vulnerable children.

Rescue

Rescuing children from the streets.

Rehabilitation

Implementing a rehabilitation program in 2 rescue centres and 2 children homes.

Reintegration

Working with the families in order to reintegrate the children back home.

Amani and Koinonia are implementing these principles through the work of:

Ndugu Mdogo and Mother House Rescue Centres, located in Kibera and Riruta Satellite: every year a group of 65 children (both boys and girls) are rescued from the street and involved in a rehabilitation program of one year.

Kivuli centre, a CCI is located in Riruta satellite. Here live former street boys who after the rehabilitation program of the two rescue centres are not yet ready to return to their families of origin. Kivuli centre is also a place of social aggregation where many other initiatives are implemented such as: a medical dispensary, that through the Riruta Health Program (RHP) also provides home medical assistance to HIV-positive patients, sensitization and awareness activities; a community radio, 'Mtaani Radio'; youth workshops; a computer school.

Anita Home, located in Ngong, was established in 1999. Anita is a CCI for former street girls and girls coming from difficult situations such as early marriages and domestic violence.

Amref Health Africa is an international African organisation headquartered in Nairobi, Kenya and established in 1957. Our vision is “Lasting health change in Africa”. Today, Amref Health Africa works with the most vulnerable communities in Africa through its country programmes in Ethiopia, Kenya, Malawi, Mozambique, South Sudan, Senegal, South Africa, Tanzania, Uganda and Zambia. Amref Health Africa has offices in North America and Europe that support with fundraising. It started as a curative organization using planes (*Amref Flying Doctors*). It has since evolved into a leading health development organization and in 2014, rebranded from African Medical and Research Foundation (AMREF) to Amref Health Africa. In 2017 it opened the Amref International University in Nairobi.

Amref Health Africa in Italy was founded in 1987, as a member of the global Amref family. The Italian office currently supports operations in Ethiopia, Kenya, Mozambique, South Sudan, Uganda and in Italy itself.

Focus in Kenya

Amref Health Africa in Kenya has operations and diverse health programmes covering all the 47 counties. Our strategic focus is to serve vulnerable and underserved populations in the country. Amref strategic focus is executed through four programme areas:

1. HIV/AIDS, TB, Malaria and Non-Communicable Diseases
2. Reproductive, Maternal, New-born, Child, Adolescents, Youth Health and Nutrition
3. Water, Hygiene, Sanitation and Neglected Tropical Diseases
4. Health Systems Strengthening

Over the 10 years of implementing the corporate Strategic Plan 2007-2017, Amref Health Africa in Kenya has carved out Community Health Systems Strengthening as its distinct area of expertise and has therefore used this advantage to forge collaborations and partnerships across the Country.

The new Strategic Plan 2018-2022 takes into consideration the burden of diseases caused by infectious diseases, non-communicable diseases and maternal and neonatal mortality; Human Resource for Health gap; the devolved system of governance; Kenya's under investment in health; vibrant youth population in Kenya; and the shift from MDGs to SDGs. In particular, it spells out Amref Health Africa leadership role in health development in supporting the Government's agenda to strengthen devolved governance and institutions for improved health service delivery by the county governments. In order to contribute to the reduction in maternal, neonatal and infant mortality and disease prevalence in Kenya, Amref Health Africa in Kenya will focus its interventions on improving HRH capacity, innovative health services improvement and advocating for increased health care financing.



L’Africa Chiama NGO was founded back in 2001. It is present in three sub-Saharan countries: Kenya, Tanzania, and Zambia where it promotes actions in favour of vulnerable children in the sectors of education, nutrition, health and hospitality.

Focus in Kenya

Since 2003 L’Africa Chiama is leading international cooperation programs in Kenya, specifically in the northern outskirts of Nairobi. The focus of the organization is within the child protection cluster. L’Africa Chiama operates on two main levels:

1. Continuative programs aimed at supporting the local communities on a regular basis through:

a. Street Children Program

The program consists of an outreach service needed for identifying street children and responding to their immediate needs and reintegration phase aimed at reuniting the child with the family.

b. Mother-to-Child Program

The aim of the project is to prevent the HIV transmission from the mother to the child during pregnancy, delivery and breastfeeding time.

c. Disability Program

The general objective of the project is to improve the motor skills and the level of education of disadvantaged and vulnerable children with disabilities.

d. Karibuni Watoto’ Program

The goal of the program is to guarantee free and good education and balanced diet for children between 6 months and 3 years old from vulnerable families.

e. Marengeta Nutritional Centre

The program gives its services to old age men and women, orphans and single mothers of Marengeta.



f. Feeding Program

Nutritional support to more than 800 primary students of the Vendramini Education Centers.

2. Targeted Supportive Interventions designed to strengthen the continuative programs to respond to specific needs

a. ‘Special Children’

An awareness campaign to prevent children joining life in the streets culminated in the original theatre piece ‘Safari ya Sufferer’ (The Sufferer’s Journey).

b. ‘Emergency Kenya’

Wide program to fight against hunger in schools and communities;

c. ‘Disability is not Inability’

Intervention of economic empowerment of families of children with disabilities through trainings and start-up of income generating activities.

and peace among Christian communities and civil society and it is organised at local (parish), diocesan, national, regional and international level. Inspired by Gospel values and the Catholic Social Teaching Caritas responds to disasters, promotes integral human development and advocates on the causes of poverty and conflict, regardless of race or religion. In Africa Caritas Italiana walks alongside the sister Churches in a process of accompaniment and mutual growth, in order to help local communities to be protagonists of their development. Particular attention is given to supporting local Caritas



bodies to strengthen the capacity for analysis and response to community participation and participation needs.

Caritas Italiana is collaborating since years with Caritas Kenya at national and diocesan level. At national level we are supporting an emergency program launched in April 2017 in response to the drought which is affecting the Country since 2015. In the past, Caritas Italiana has supported a multi-sector programme of Kenya's National Caritas in response to the 2011 food crisis to promote an adequate access to food, water resources and sanitation; activities to strengthen

Caritas Italiana promotes a twinning program which involves Italian and Kenyan diocesan Caritas.


In Italy we strive to abolish the cultural barriers and the lack of information preventing the most vulnerable people like migrants and recent poor from accessing health services.

Focus in Kenya

CCM has been working in Kenya since the Seventies focusing mainly in the northern areas of the Country. Since 2014 CCM has been adopting an integrated approach to the achievement of Kenya Government strategic plans and United Nations Millennium Development and Sustainable Goals focusing on health-related topics and determinants in Isiolo and Nairobi County. In Isiolo CCM focused on access to safe water and to primary health care services in partnership with LVIA NGO. Pastoralist communities have been sensitized on personal hygiene and healthy practices at school, health facility and community level, while level 2 and 3 health facilities were empowered through capacity building of staffs and supply of basic equipment. Specific focus was given to mother, neonatal and child health (MNCH). In Nairobi County, CCM has been focusing on vulnerable youth living in urban informal settlements and minor refugees. In partnership with GRT NGO and the local authorities for health and child protection, CCM aims at contributing to the access of vulnerable youth and children to health and social services, with specific focus to street children.

The approach in these sectors is focused on generating self-reliance and sustainable processes within rural communities. CEFA promotes autonomous economic and social structures (cooperatives, social cooperatives, microcredit or Group Saving & Loans etc.) with the aim of modifying the agriculture productive structures and strengthening strategic value chains.

Child Protection and Juvenile Justice

Child Protection is one of the pillars of CEFA Kenya and based on an expertise matured since 2005. CEFA's vision in this sector is to build a society in which children's rights are respected and where every child is granted prevention and protection from any kind of violence, including neglect and inadequate access to their rights. Our strategy is focused on the establishment of mechanism of social dialogue, networking and transfer of knowledge and skills, in order to promote structural reforms and ensure a violence-free society to children.

Human rights in Prison

In addressing human rights challenges, CEFA strategy aims at strengthening the Government Departments and other Non-State Actors by embracing a holistic approach and establishing mechanisms of social dialogue and networking.

Art and Culture

Since 2014 CEFA started the implementation of projects focused on the protection and promotion of Art and Culture, viewed as an opportunity of employment for those coming from vulnerable backgrounds and as a means to improve social well-being for the communities.

Focus in Kenya

Juvenile Justice

Cesvi is active in reducing every form of violence against minors in the National Justice System. In 2016, a project related to the reform of the judicial system was concluded. This was possible through the national coordination of police, the judicial system and the national services for minors (counseling, healthcare and education for youth with disabilities) and by providing training activities for public employees. The project has involved local communities, the national department of minors and - in regards to people who are on probation - police, juvenile courts of justice, protection services, shelters and rehabilitation centers.

Fight against Child Labour

The operation in Kenya aimed at reinforcing, in the urban and rural areas, the government, authorities and local communities and to get the private sector involved in the fight against child labour thus creating pilot areas free from these forms of exploitation. Cesvi developed a company "Child Labour Free" standard based on monitoring production chains and has contributed to the creation of more than 70 "Child Labour Free" villages. The other area of involvement concerns the abolishment of every form of violence towards minors in the National Justice System. The activities which involved local communities, the national department for minors, the department of probation, the police, the minors' courts, protection services in the counties and in reception and rehabilitation centres, aimed at the reintegration of minors into their families and the support of social services.

CISP is an Italian Non-Governmental Organization established in 1983 with head office in Rome. In cooperation with local and international partners, the organization carries out projects in the area of humanitarian assistance, rehabilitation and development in over 30 countries in Africa, Latin America, the Caribbean, Asia, the Middle East, and Europe. The mission is to contribute to the realization of development conditions for the self-determination of peoples, by ensuring the respect, protection and fulfillment of human rights while fighting against social exclusion.

Focus in Kenya

CISP's activities in Kenya started in 1997 with an income generation project in Thika. In 20 years of operations CISP has spread its activities in different regions of the country, both in rural and urban areas, and expanded its programmes in various sectors of interventions.

Education

CISP intervention aims to increasing inclusive access of children and youth to quality education at the level of:

Early Childhood Development Centers, by enhancing the skills of teachers accessing teacher's training colleges and supporting communities to build Early-Childhood Education Center.

Higher education, through the Master in Economics – Cooperation and Human Development (MECOHD), established in 2013 and run in partnership by the Cooperation and Development Network, Kenyatta University, Tangaza University College and UNDP.

Health and Nutrition

CISP initiatives are aimed at promoting the rights of the most vulnerable groups of the population to access affordable and quality health care and services. CISP work focuses on Participatory Advocacy, Knowledge Management, and Stakeholder's Coordination to enhance health and nutrition service provision in Kajiado, Kwale, Kilifi and Kitui Counties.

Child Protection

The child protection program focuses on provision of quality services in the Child Protection Centres in Kilifi and Nakuru county and the prevention of child abuse, exploitation and violence through social change and empowerment innovative approaches as well as advocacy actions based on research findings.

Governance

CISP supports the devolution by increasing the capacity of County Authorities and Civil Society Organizations to manage county affairs through accountable and transparent processes and by developing effective public participation mechanisms in decision making processes at grass-root and county level.

Migration

In the sub-Saharan region, the ItRC collaborates with the National Red Cross Societies of Kenya, Ethiopia, Somalia, Malawi, Madagascar, Mauritius, Mozambique, Botswana, Senegal, Gambia, Sierra Leone and Cameroon. Since May 2017, the ItRC Regional Delegation for Africa is based in Nairobi, Kenya.

Focus in Kenya

Integrated Health and Nutrition in North-East Turkana

Between November 2013 and August 2015, in partnership with the Kenya Red Cross Society (KRCS), the ItRC has supported the design and the implementation of the project 'Integrated Health and Nutrition in North East Turkana, Kaikor Health Infrastructural Support'. The project aimed at increasing the access to integrated basic health care services to individuals in one of the most drought-prone areas of Kenya, Turkana County, in order to reduce excess morbidity, mortality and malnutrition caused by the drought, which increased since April 2014.

Harm Reduction in Lamu County

Since July 2016, the ItRC collaborates with the KRCS on the design and the implementation of the project 'Harm Reduction in Lamu County'. The project aims at: contributing to the reduction and mitigation of the impact of narcotics use and abuse in the Kenyan coast region; preventing massive opioid withdrawal-related morbidities and mortalities among the people who use drugs (PWUD); enhancing community empowerment in addressing and reintegrating the recovering PWUD back into the society. The project will provide PWUD and their families a comprehensive package of services that will take place at the rehabilitation centre that has been built.

FADV is an international development organization operating in Italy and internationally with the primary objective of promoting and protecting children basic rights and wellbeing. The organization works towards improving the children's family and social environment and towards creating a safe system for his/her effective growth. Internationally, FADV's operational area currently includes Italy, India, Nepal, Bangladesh, Perù, Kenya, Haiti, Libya.

Focus in Kenya

In Kenya, FADV has been working since 2010 in the Juvenile Justice system, supporting the Children Government Statutory Institutions in order to improve life conditions of children in conflict with the law and other children in need of care and protection. Between 2016-2017, with



the financial support of AICS and in collaboration with the Department of Children's Services, Department of Probation and Aftercare and the local partner Collective Community Action (CCA), the previous intervention has been expanded reaching 8 Children Government Statutory Institutions in the counties of Nyeri, Kiambu and Nairobi. In 2018 a more comprehensive project has started, with the financial support of AICS and with several local and international stakeholders and Government counterparts. The focus of this action is on Restorative Justice, Alternative Dispute Resolutions and Alternative Care aiming at deinstitutionalization (as in line with the Government strategy) and at reducing the number of children entering in the Juvenile Justice System, as well as of those recidivist.

In order to ensure well-being to all children, FADV in Kenya has implemented several action in the informal settlements of Nairobi (Kayole, Korogocho and Mathare) through health and food security interventions, in particular, with the Mother and Child Health program and food and nutrition security activities.

In Samburu County, an ASAL area, FADV intervention has been focusing on Emergency and Development programs, through the perspective of a climate-change adaptation, with particular focus on food and water supply and distribution. FADV aims at strengthening the resilience of pastoral communities on food security. Likewise, FADV has been implementing activities in Samburu County with the purpose of strengthening education, school inclusion and preventing harmful practices.

GRT was established in 1968 in Milan as a trans-cultural research institute. Since its foundation, it has been working with socially marginalized groups and individuals by setting up protection mechanisms in order to promote social inclusion. The main areas of expertise are mental health and psychosocial support, protection (gender-based violence and street children) and support to ethnic minorities. The first projects GRT implemented were in Madagascar and Central America, mostly focusing on the interaction between traditional medicine and mental health. Since the beginning, GRT has been using an inclusive approach, where local communities have been involved in the projects since their early stages allowing local ownership and paving the way to piloting system of social welfare. GRT has been working in Nicaragua, Guatemala, Nepal, Mali, Cameroon, Kenya, Romania, Italy and Somalia. In the latter in particular, GRT's leading

Focus in Kenya

GRT has been active in Kenya since 1996, initially as part of UNA, a consortium of 6 Italian NGOs, and afterwards as a standalone NGO working in Kenya and Somalia. Within the consortium, GRT with its specialized expertise in the psychosocial sector, took into special account the cultural and traditional aspects of Kenya and carried out projects and activities in a trans-cultural perspective, focusing its interventions mainly on mental health and child protection.

From 2012 the organization started to implement projects focusing on improving the life conditions of street children in the slums of Nairobi (Waithaka, Dagoretti, Mlango Kubwa, Mathare). The first programme with street children started to enhance the empowerment and capacity building of Slum Drummers CBO: a group of young drummers whose goal is to share musical practices and social topics with young people by encouraging them to stay away from drugs, alcohol and all the risk they can face in the slums. Moreover, from 2017 GRT is implementing, in partnership with CCM - Comitato Collaborazione Medica and Heshima Kenya, a 36-months project named "Boresha Maisha: Alternatives of life for street children and underage refugees in Nairobi", in the slums of Mlango Kubwa and Eastleigh. The project aims to activate the mechanisms of health and social protection, rehabilitation and community reintegration of street children from Mlango Kubwa and surroundings.

Food Security:

Karibuni Onlus is very sensitive on the resilience of the community, one of the pillar of the ngo is to make sure the community will not be affected by the natural calamities that are common in the area where the project are implemented. There are project of food resilience and micro finance in Meru. Langobaya, in Malindi Sub-County, has the biggest project in this sector, where almost 70 acres (42 in Kilifi and Ukunda) are farmed and are used as demonstration farms to train the community on the best practises and how to deal with climate change and challenges of the same area.

There is also a project on livestock whereby goats and chicken are kept to create an income to sustain the projects and they are used to understand the local disease and show the community how to cope with them and the best way of goats and chicken farming.

Education

Karibuni Onlus is supporting a Primary School and a ECDE in Meru. The organization works in education sector together with 4 public schools of the area of Malindi sub county. In te same county it supports the education through infrastructure and feeding program.

Karibuni Onlus also supported university students until the graduation.

Since its arrival in Kenya, Mo.C.I. collaborates with the Diocese of Machakos. It maintains relationships especially with the Caritas office, with which it discusses the interventions and methodologies to be applied in the various projects.

Kathonzweni, Makueni

The interventions have been more addressed to a Small Home (home for disabled children in school age), called "Rainbow". Since 2006, the Small Home has been supported to improve the diet of the host children, the financing of vegetable garden to assure food sovereignty and a restructuring project to break down the



architectural barriers and make facilities more accessible for disabled children. In 2010, an art therapy project was started in collaboration with the Wajukuu Art Project Association. Local partner of the project is the Congregation of the Most Precious Blood Sisters.

Wote, Makueni

In Wote, the interventions were directed to St. Patrick's M.V.T.R.C. (Makueni Vocational Training and Rehabilitation Center), a vocational school for disabled children, which offers various training courses like tailoring, shoe-making, knitting, leather work, weaving of textiles and information technology, in order to make the guests boys self-reliant.

Mukuru Slum, Nairobi

In 2009, the collaboration with the Association Wajukuu Art Project was started. It was formed by young artists who were born and raised in the slum of Mukuru. The Wajukuu Art Project is committed to the empowerment of its community, through the use of art by means of expression. It mainly organizes social and educational activities aimed at children and young people of the slum, in order to enhance and develop their talents and create places of aggregation and sociality within a community at risk, since there are many difficulties deriving from living in a shantytown (drugs, crime, abuse).

Kibera Slum, Nairobi

In 2007, a collaboration was born with the Colombian religious congregation of "Yarumal" present in the slum of Kibera with some training houses for the seminarians. Mo.C.I. supports youth in the slum in their schooling and has supported various agricultural projects proposed by the same congregation over the years.

Tumaini Children's Home is a International Cooperation Project required to OSVIC in 2003 from the Archdioceses of Nyeri and started in 2004. Beforehand, the organism has been present in Kenya in different areas like Ngarenmara, Isiolo and Marsabit. OSVIC achieved various International Cooperation Project co-funded by MAECI and UE in Cameroon, Equatorial Guinea, Morocco, Perù, Argentina, Uruguay and Honduras.

Focus in Kenya

Since its foundation, the Tumaini Children's Home has been committed in the seropositive child' protection of Laikipia County, working closely with local communities. From the beginning to today, important results have been realized, both regarding the state of health of the children assisted in the Institution and their inclusion in the social fabric. It targets HIV positive orphans born with the virus and only admits children of between 4 and 12 years of age.

Currently, the home has a population of 42 as of Feb 2018 although the admissions are still in progress.

These beneficiaries live in the Institution but break for holidays to their respective guardians in preparation for exit from the Home after completing their primary education.

At the home, the following services are provided: Shelter/Accommodation, Food, Health/Medical, Education, Clothing, Spiritual and Psycho-social Support. The main purpose is to accompany the children in a path of growth at 360 degrees: human, social and spiritual, until the end of primary school. The key point of this path is the importance of taking care of oneself, through a correct lifestyle that includes also the promotion of one's own talents and self-confidence as the first element to fight discrimination and the stigma that still today HIV entails. After their exit from the home, Tumaini still supports some of them in their secondary and technical education. The institution also supports other 25 needy children at the Home based Care Program whereby children infected and affected with the HIV virus cannot be admitted in the Home due to the limited capacity hence supported at the community level without need for admission

Terre Solidali (TS) was created in 2002 by a group of professionals having consolidated working experience in the humanitarian aid and development sectors with the common objective of enhancing local resources by reinforcing the Civil Society and the Public Institutions, through the joint implementation of projects.

TS Vision is to establish sustainable access, use and management of local and natural resources as well as consolidated, modern and transparent financial management systems across different public institutions, PPP and private urban and rural service providers, through formal and on-the-job training, emphasising on new technologies and capacity building of local resources. Terre Solidali is present in Italy, Niger, Mauritania, Kenya and Somalia.

Focus in Kenya

The Eastern Africa HQs of TS in Nairobi is providing administrative support to the projects in the region, mainly in Somalia, and liaison with major institutional donors.

On a voluntary basis, TS availed the expertise of its professionals to local and international partners to support their financial management and water-related interventions in Kenya.

TS directly operates in Nairobi supporting disadvantaged children in the suburban areas, in Naro Moru at the Disabled Children's Home and in Wamba to solve a chronic problem of water shortage.

With the support of an Italian theatre director, TS developed a technique to introduce theatrical therapy to enhance the effectiveness of the physiotherapy activities, and their smooth acceptance by the disabled children.

The same technique has proven to be successful

with children having special education needs. Socio-rehabilitative therapies facilitate the reintegration process combining physical therapy activities that enable the development of self-awareness, sociality and creativity.

The Theatrical Therapy supports the rehabilitation of the body and the person too, essential aspects to re-gain a position in a rural community and to enhance the inclusion in the normal streams of the over-populated schools in the suburbs of a town.

From 2018 it partners with a local CBO based in Watamu to implement a project on Life Skill and Youth empowerment which will be implemented in 3 schools within Kilifi county.

The aim is to assist children with practical tools on decision making and life trying to minimize the problem of early pregnancy, school drop-outs, drug abuse and sensitize them on sexual health and STI.

Twins International is an Italian private, apolitical charity born in Italy and operating in Kenya. Created by Mrs. Daria and Mr. Diego Masi, it is a charity governed by 10 executive Board members and 25 General Assembly associates. Since 2007, Alice for Children by Twins international has been developing projects in Kenya for vulnerable and disadvantaged children. In aggregate, it supports about 3000 children in the informal settlements of Nairobi such as Korogocho and Dandora, as well as in the Rombo District, a rural area at the border with Tanzania. Since 2006, the organization has supported three schools. The first school for about 1000 children is in Korogocho. The second one gives a quality education to more than 500 children and is located in Dandora. Here, it was inaugurated a counselling drop-in center for young pupils and their families, who work in the dumping site and live in conditions of extreme poverty. The third, is a school for over 600 Maasai children in the Rombo District at the feet of Mount Kilimanjaro. In the outskirt of Nairobi the organization built three Children Homes: Alice Village and Alice Twins House in Utawala, Alice Home in Kariobangi (closed in 2015), where children from extremely vulnerable families, or children whose parents live in shelters or have been jailed, can be hosted and be involved in reintegration and foster care programs.

Focus in Kenya

Twins International, a Milan-based charity, has been operating in Kenya since 2007, developing education and food security programs. "Alice For Children" projects are meant for the protection of the most vulnerable children in Nairobi and at the feet of Mount Kilimanjaro. Twins International sponsors full education schemes for over 3000 children through two Primary Schools in the informal settlement of Korogocho and Dandora, one Primary School in Rombo, a rural district at the border with Tanzania. Furthermore, Twins International provides every beneficiary of its projects with an adequate health care. In the most critical cases, it offers them a safe place in one of the two Children Homes in the outskirts of Nairobi, Alice Village and Alice Twins House. Twins International is also working on three special programs: Alice Music Academy, in Dandora informal settlement, focused on supporting children's personal expression through music. Alice Baby Care, a new centre focused on hosting those children being from 0 to 3 years old, whom mothers work in the Dandora dumpsite. Alice Italian Food Academy, an Italian food specialized school created to help our beneficiaries find an occupation

Focus in Kenya

WKO focuses on 5 main sectors:

Alternative Family Care

WKO has been operating a children home for the last 12 years, which has been closed in 2017 to be reconverted into a boarding school for a public primary school, intended to improve the result of class 8 students during their final exams.

From 2017, WKO converted the Children Home Project into Alternative Family Care, mainly through kinship care. WKO has reintegrated the 35 children into their family and support them through economical and social intervention.

Education

One of the pillars of WKO is to improve the life of people through their personal development.

WKO is supporting 2 students at university level; 6 students in secondary schools; 30 in primary schools; 5 in special school (mentally disabled and deaf and dumb).

WKO also supports public primary schools in a rural area, where the organization has been supporting the teaching staff with 1 teacher, the connection to the main water pipeline, the renovation of classrooms and teaching material if needed. We are also supporting the boarding for 43 students of class 8.

Feeding Programme

WKO is providing breakfast and dinner to the 43 students on boarding and it is offering a lunch programme at Ganidini Primary School feeding 500 children every day and giving porridge to 150 children from the EDCE department.

It is very important because in this locality it is usually the only meal the children get in one day.

WASH - Dignity Kits

WKO is implementing a project addressed to schoolgirls to improve their dignity and their school participation by providing them with sanitary pads. WKO economic project (a tailoring factory) is the producer of the washable sanitary pads distributed to the school girls.

Economic Empowerment

WKO has supported the realization of a Tailoring project, from the donation of sewing machines, the training of tailors and supporting them to market their products. Five tailors are currently working in the projects.
