(1) Subject

- 1.1 The subject of this contract is the realization of video clips on mango supply chain in Makueni county with identification number CIG ZEB355463E
- 1.2 The contractor shall execute the tasks assigned to him in accordance with the terms of reference annexed to the contract (Annex II: Terms of Reference – TOR)

(2) Contract value

This contract, established in Kenya Shillings (KSH), is a global price contract. The contract value is **KSH 1,260,000** VAT included to be considered exhaustive of all expenses incurred (board, lodging and transfers) during the mission in Makueni county, as defined per the mission agenda proposed by the Contracting Authority.

(3) Order of precedence of contract documents

The following documents shall be deemed to form and be read and construed as part of this contract, in the following order of precedence:

- the contract agreement;
- the special conditions;
- the general conditions (**Annex I**);
- the terms of reference -TOR (**Annex II**);
- Economic Offer (**Annex V**);
- Other relevant forms and documents:
 - a. Declaration of honour, Single requirements document (**Annex VI_A**);
 - b. Privacy statement (**Annex VI_B**);
 - c. Integrity Pact (**Annex VI_C**);
 - d. Declaration on traceability (**Annex VI_D**).

These above listed documents make up the contract. They shall be deemed to be mutually explanatory. In cases of ambiguity or divergence, they shall prevail in the order in which they appear above. Addenda shall have the order of precedence of the document they are amending.

(4) Language of the contract

The language of the contract and of all written communications between the contractor and the contracting authority shall be English.

(5) Other specific conditions applying to the contract
