Article 1 Subject

- 1.1 The subject of this contract is the provision of helicopter chartering service from Nairobi to Sigor (West Pokot) – round trip (“the services”).
- 1.2 The contractor shall execute the tasks assigned to him in accordance with the terms of reference annexed to the contract (Annex II_ToR)

(2) Contract value

This contract, established in Ksh, is a global price contract. The contract value is USD 11.000,00 net of indirect taxes (VAT)

(3) Order of precedence of contract documents

The following documents shall be deemed to form and be read and construed as part of this contract, in the following order of precedence:

- the contract agreement;
- the special conditions;
- the general conditions (Annex I);



- the terms of reference ToR (Annex II);
- Economic Offer (Annex V);
- Other relevant forms and documents
 - a. Declaration of honour, "Documento Unico dei Requisiti" (Annex VI_A)
 - b. Privacy statement (Annex VI_B).
 - c. Integrity Pact, "Patto d'integrità" (Annex VI_C).

These above listed documents make up the contract. They shall be deemed to be mutually explanatory. In cases of ambiguity or divergence, they shall prevail in the order in which they appear above. Addenda shall have the order of precedence of the document they are amending.

(4) Language of the contract

The language of the contract and of all written communications between the contractor and the contracting authority shall be English.


